General: Based on review of documentation, a caregiver hired 08/20/19, did not have education verification on file.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of documentation, a caregiver hired 02/05/18, completed eleven (11) hours of annual training. A caregiver hired 10/09/17, completed thirteen (13) hours of annual training. A caregiver hired completed ten and half (10.5) hours of annual training.

A caregiver hired 12/13/18, completed one and half (1.5) hours of training; a caregiver hired 10/09/18, completed seven (7) hours of training; a caregiver hired 10/02/18, completed four (4) hours of training and a caregiver hired 09/02/18, completed eight and half (8.5) hours of training during their first year of employment.

General: Based on observation, a caregiver's purse hung on the handrail, accessible to children, at the steps the toddlers' room door.

- 5. Easily cleaned; and
- 6. Free of any items not used for diaper changing.

Findings:

General: Based on observation, there was no padded surface on the pull down changing station on the wall in the preschool restroom. Interview revealed the changing station was used daily.

- (a) Stored in a separate and locked place, out of the reach of a child unless the medication is:
- 1. A first aid supply and is maintained in accordance with subsection (1) of this section;
- 2. Diaper cream, sunscreen, or toothpaste. Diaper cream, sunscreen, or toothpaste shall be inaccessible to a child;
- 3. An epinephrine auto-injector. A licensed child-care center shall comply with KRS 199.8951 and 311.646, including:
- a. An epinephrine auto-injector shall be inaccessible to a child;
- b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
 - c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
- d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 12(1)(b) if an epinephrine auto-injector is administered to a child: or
- 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

General: Based on observation, a tube of diaper cream was in a child's cubbie and not stored in a locked place in the toddlers' room.

Findings:

General: Based on observation, there was rust which covered the floor vent in the preschool restroom. A Bumbo seat was on the floor in the younger infants' room. A review of the Consumer Product Safety Commission recall information determined the Bumbo seat was recalled in 2007 and instructed consumers to order a free repair kit which included a restraint belt and a warning label. Interview determined the center was not aware of the recall and used the Bumbo seat daily.
