For a school-age child, within scope of vision or range of voice;</b></p> <p><b>Findings:</b><br/>                     General: Based on interview and review of documentation, it was determined that a three-year-old child was left unsupervised on the facility playground from 10:17 a.m. until 11:17 a.m. The child did not follow his classmates inside after the students had been lined up. The staff member in charge of the classroom did not notice that the child was missing prior to being dismissed for their lunch break. Neither staff member responsible for the children during the hour that the child was left unsupervised had reviewed the clipboard listing the class roster of children present to ensure that all 12 students were accounted for upon entry to the classroom.</p> |                          |

The recorded temperature during this incident was 82 to 84 degrees Fahrenheit with a relative humidity of 73 -75%. The child did not have access to water while on the playground. The staff member who had located the child described the temperature as "uncomfortably warm" and noted that a heat advisory was issued later in the day. It is unknown whether the heat advisory was in effect during the times listed above.</p>                                     |                          |
