General: Based on Review of Documentation, a staff, hired on 07/18/16, and a staff, hired on 12/13/16, did not have education verification on file.

- (14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 $\frac{1}{2}$) hours of pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 $\frac{1}{2}$) hours of pediatric abusive head trauma training completed once every five (5) years.

General: Based on Review of Documentation, a staff, hired on 07/18/16, did not complete six (6) hours of cabinet approved training. A staff, hired on 05/17/00, completed fourteen and a half (14 ½) hours of cabinet approved training hours. A staff, hire on 02/01/07, completed twelve (12) hours of cabinet approved training hours.

General: Based on Observation, an accumulation of dust was in the air vent in the toddlers' restroom.

General: Based on Observation, dead bugs were inside two (2) light shields in the infants' room. In addition, dead bugs were inside three (3) light shields in the toddlers' room and in a light shield in the toddlers' restroom.

- (3) A sink shall be:
- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;
- (f) Equipped with an easily cleanable waste receptacle; and
- (g) Immediately adjacent to a changing area used for infants and toddlers.

Findings:

General: Based on Observation, the hot water temperature registered eight-two (82) degrees Fahrenheit at a sink in the toddlers' room.
