Due to the current declared public health emergency caused by the Novel Coronavirus Disease (COVID-19), licensed child care centers must operate under Centers for Disease Control and Prevention and public health guidelines, as mandated by 922 KAR 2:410E, to prevent the spread of COVID-19.

Findings:

General: Based on review of documentation and interview, the center failed to assure all child care staff completed a mandatory training on cleaning, sanitizing, health procedures, and mandatory reporting prior to the center reopening and all new staff hired shall complete the mandatory training on cleaning, sanitizing, health procedures, and mandatory reporting within ninety (90) days of their hire date. Four (4) staff members hired 03/19/2019, 03/01/2011, 10/26/2020 and 09/09/2020 failed to complete the mandatory training.
