For a school-age child, within scope of vision or range of voice;</b></p> <p><b>Findings:</b></p> <p>TYPE B CITATION: Based on Interview, a child was left unsupervised on 2/27/14. There were two (2) staff with a group of seven (7) two (2) year olds. One (1) staff person took a child to the bathroom and the other staff was to bring the rest of the children. However, while in the bathroom it was realized that one (1) child was not with the group. One (1) staff person returned to the classroom and found the child there alone. The staff involved estimate the time the child was left unsupervised to have been about five (5) minutes as she had changed three (3) children's diapers during this timeframe. The bathroom is located diagonally across the hall from the classroom.</p>
