## Findings:

General: Based on Review of Documentation, the child care center director failed to assure compliance with regulatory requirements. A review of staff files revealed files for staff members with hire dates of 6/25/15, 5/28/15, 7/14/97,/12/22/99, and 2/5/15 failed to contain documentation assessing each person's interaction with children in care and classroom performance. Interview with the staff- in- charge revealed that the director had not completed these evaluations.

- (14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 1/2) hours of pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1  $\frac{1}{2}$ ) hours of pediatric abusive head trauma training completed once every five (5) years.

## Findings:

General: Based on Review of Documentation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Upon review of all staff records and interview with staff in charge, Pediatric Abusive Head Trauma (PAHT) has not been taken by all staff members in their first year of employment. Interview with staff in charge stated that none of the staff have had PAHT training.
