Director Requirements and Responsibilities.</b></p> <p><b>(1) A director shall:</b></p> <p><b>(e) Manage the staff in their individual job descriptions;</b></p> <p><b>(f) Assure the development, implementation, and monitoring of child-care center plans, policies, and procedures;</b></p> <p><b>(g) Supervise staff conduct to ensure implementation of program policies and procedures;</b></p> <p><b>Findings:</b></p> <p>General: Based on interview and review of documentation, the center's disciplinary policy stated, "Children will not be subjected to harsh or physical discipline, nor shall any methods of discipline be used that are humiliating, threatening, shaming, or frightening. Employees will use positive reinforcement and praise for children exhibiting desirable behaviors. Staff will maintain a calm and professional demeanor when disciplining a child." The center's discipline policy was not followed when a caregiver told a child to stop crying because she heard enough of it while they were in the restroom on 03/18/2020. Another caregiver noticed red marks on the child's left and right cheeks. The caregiver who took the child to the restroom admitted she held the child's face.</p>

The caregiver held the child's face and yelled at the child. The caregiver and child exited the restroom, and red marks were observed on the left and right cheeks of the child's face.</p>

**922 KAR 2:120. Section 2. Child Care Services.**

**(10) A child shall not be subjected to:**

- (a) Corporal physical discipline pursuant to KRS 199.896(18);**
- (b) Loud, profane, threatening, frightening, humiliating, or abusive language; or**
- (c) Discipline that is associated with:**
  - 1. Rest;**
  - 2. Toileting; or**
  - 3. Food.**

**Findings:**

General: Based on interview, a caregiver yelled stop crying to a two-year-old child while in the two-year-olds' restroom on 3/18/2020. Two (2) caregivers overheard the caregiver use a loud, frightening tone towards the child.
