(1) An infant shall sleep or nap on the infant's back unless the infant's health professional signs a waiver that states the infant requires an alternate sleeping position.

Findings:

General: Based on observation, interview and review of documentation, an infant slept in a bouncy seat inside a crib for approximately fifty (50) minutes in the infants' room. A signed waiver from a health professional that stated the infant required an alternate sleep position was not on file.

General: Based on observation, an infant slept in a crib with a fabric pacifier clip attached to the infant's pacifier and shirt in the infants' room.

Four (4), two-year-old children and three (3), three-year-old children did not wash their hands with liquid soap and warm running water once they returned to their respective classroom from outdoor play.
