922 KAR 2:090. Section 10. Director Requirements and Responsibilities.

(1) A director shall:

- (e) Manage the staff in their individual job descriptions;**
- (f) Assure the development, implementation, and monitoring of child-care center plans, policies, and procedures;**
- (g) Supervise staff conduct to ensure implementation of program policies and procedures;**

Findings:

General: Based on interview and review of documentation, the center's discipline policy stated disciplinary methods will be designed and implemented through positive guidance to help each child develop self-control and assume responsibility for his/her actions. Children will not be subjected to harsh or physical discipline nor will any methods of discipline be used that are humiliating, threatening, shaming or frightening. Staff will use methods of positive redirection. The discipline policy was not followed when a staff person swatted/spanked a one-year-old child on the butt through her pants and diaper with her hand at 11:00 am on 4/7/21.

360 - Caregiver Alone

922 KAR 2:090. Section 10. Director Requirements and Responsibilities.

(1) A director shall:

- (m) Assure that a person acting as a caregiver of a child in care shall not be left alone with a child, if the licensee has not received the results of the background checks as described in 922 KAR 2:280;**

Findings:

General: Based on observation, a review of documentation and interview, a caregiver hired on 3/9/21, supervised seven (7) children alone from 12:00 pm to 1:25 pm in the toddlers' room. The caregiver did not have a child abuse neglect check on file.

Emergency Regulation

1265 - Emergency Regulation

Not In Compliance

922 KAR 2:415E. Emergency Regulation.

Due to the current declared public health emergency caused by the Novel Coronavirus Disease (COVID-19), licensed child care centers must operate under Centers for Disease Control and Prevention and public health guidelines, as mandated by 922 KAR 2:415E, to prevent the spread of COVID-19.

Findings:

General: Based on observation, a review of documentation and interview, the center failed to assure new staff shall undergo name-based background in accordance with 922 KAR 2:280 and shall not be left alone with children until name-based background checks have been approved and returned in accordance with 922 KAR 2:415E. Caregivers hired 3/9/21 and 3/17/21, did not have documentation to verify a child abuse/neglect check had been submitted. In addition, a caregiver hired on 3/9/21, supervised seven (7) children alone from 12:00 pm to 1:25 pm in the toddlers' room.
