Based upon record review, interview and observation, the child care center failed to comply with Director Requirements assuring that any caregiver of a child shall not be left alone with a child if the licensee has not received background check results required by regulation. Record review of the Child Abuse and Neglect (CAN)application for a staff member with a hire date of 02/23/16 revealed that she currently resides in Indiana. Interview with the staff member confirmed that she still resides in Indiana. Observation during survey revealed that she worked alone as the sole caregiver in the Infant/Toddler room.

General: Based on review of documentation, interview and observation, the child care center failed to comply with regulatory requirements regarding background checks. Record review revealed a staff member with a hire date of 0f 02/23/16 resides in Indiana did not have an out-of state criminal background check in her employee records. Interview with the staff member confirmed that she still currently resides in Indiana. Observation revealed this staff member was the lone staff member in charge of the Infant room, which was a self contained classroom separate and apart from the other two class rooms.


