1. On 8/19/13 a staff person bit a toddler on the upper right arm leaving a red mark and teeth indentions on the child's arm.
2. A staff person disciplines the children, whose ages range from ten to twenty-nine (10-29) months by "spanking" them on their "butts and legs".
