**922 KAR 2:090. Section 11. Staff Requirements.**  
**(16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:**  
**(a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;**  
**(b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and**  
**(c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.**

**Findings:**

General: Based on review of documentation and ECE - TRIS, the surveyor found the following:

- (1.) Staff (DOH: 6/2/15) obtained pediatric abusive head trauma training on 7/17/13. The staff needs to take the training again as the training is required once every five (5) years.
- (2.) Staff (DOH: 7/24/15) obtained pediatric abusive head trauma training on 7/18/13. The staff needs to take the training again as the training is required once every five (5) years.
- (3.) No documentation was found to verify a staff (DOH: 9/1/17) obtained the one and one-half (1 1/2) hours of pediatric abusive head trauma training within their first year of employment.
