922 KAR 2:110. Section 6. Reports.

- (1) The following shall be reported to the cabinet or designee and other agencies specified in this section within twenty-four (24) hours from the time of discovery:
 - (a) Communicable disease, which shall also be reported to the local health department pursuant to KRS 214.010;
 - (b) An accident or injury to a child that requires medical care;
 - (c) An incident that results in legal action by or against the child-care center that:
 - 1. Affects a child or staff person; or
 - 2. Includes the center's discontinuation or disqualification from a governmental assistance program due to fraud or abuse;
- (d) An incident involving fire or other emergency, including a vehicular accident when the center is transporting a child receiving child care services; or
- (e) A report of child abuse or neglect that:

Findings:

General: Based on interview, child care center staff failed to report two (2) separate incidents of suspected abuse or neglect of a child. One (1) parent reported concerns in August of 2016 to the center Director in regards to one (1) staff member (DOH: 09/21/15) "squeezing" a four-year-old child's hand. Another parent reported concerns to the center Director in regards to one (1) staff member (DOH: 09/21/15) allegedly "hitting" a two-year-old child on the legs and arms. Upon interview, the Director reported that she did not report the allegations due to there being no marks or bruising on the children. The Director did not provide any documentation concerning either allegation.
