General: Based on review of documentation, six staff were missing documentation of education.

- 4. Stories and books;**
- 5. Science or nature;**
- 6. Block building or stacking;**
- 7. Tactile or sensory activity;**
- 8. Multi-cultural exposure;**
- 9. Indoor and outdoor play in which a child makes use of both small and large muscles;**
- 10. A balance of active and quiet play, including group and individual activity;**
- 11. An opportunity for a child to:**
 - a. Have some free choice of activities;**
 - b. If desired, play apart from the group at times;**

General: Based on observation, a schedule of activities, including dates and list of activities, was not posted in either classroom. Also, each classroom did not have any multi-cultural items.

General: Based on review of documentation, seven children did not have evidence of an updated immunization record on file at the facility.

General: Based on review of documentation, there was no evidence of the facility's Emergency Preparedness plan or evidence that it had been submitted to the proper authority for review.

General: Based on review of documentation, seven staff did not have documentation of a professional development plan on file at the facility.

Findings:

General: Based on review of documentation, there was no documentation provided at the time of inspection of any drills being conducted.

General: Based on review of documentation, there was no documentation of an orientation policy on file at the facility.

- (b) Each statement of deficiency and civil penalty notice issued by the cabinet during the current licensure year;**
- (c) Each plan of correction submitted by the child-care center to the cabinet during the current licensure year;**
- (d) Information on the Kentucky Consumer Product Safety Program and the program's Web site as specified in KRS 199.897;**
- (e) A description of services provided by the child-care center, including:**
 - 1. Current rates for child care; and**
 - 2. Each service charged separately and in addition to the basic rate for child care;**
- (f) Minimum staff-to-child ratios and group size established in 922 KAR 2:120; and**
- (g) Daily planned program.**

Findings:

General: Based on observation, the facility did not have the previous statement of deficiency or plan of correction from the relicensure posted at the facility. In addition, there was no information from the Kentucky Consumer Product Safety Program or rates posted at the facility.

1325 - Daily Activities
