General: Based on review of documentation, the following was found:

- (1) A staff member (DOH: 11/20/98) completed only twelve (12) hours of cabinet-approved early care and education training within the past year of employment.
- (2) A staff member (DOH: 3/10/03) completed only four (4) hours of cabinet-approved early care and education training within the past year of employment.
- (3) Five (5) staff members (DOH: 5/8/00, 6/27/01, 8/25/07, 6/30/09, and 8/9/10)) completed only six (6) hours of cabinet-approved early care and education training within the past
- (4) A staff member (DOH: 8/20/11) completed only six (6) hours of cabinet-approved early care and education training in addition to orientation within the first year of employment.
