**922 KAR 2:120. Section 7. First Aid and Medicine.**  
**(6) Medication, including refrigerated medication, shall be:**  
 (a) Stored in a separate and locked place, out of the reach of a child;  
 (b) Kept in the original bottle; and  
 (c) Properly labeled.  
**(7) Medication shall not be given to a child if the expiration date on the bottle has passed.**

**Findings:**

General: Based on observation, during a tour of the kitchen, the surveyor found a small vial of Epogen, located in the butter compartment of the refrigerator door. In an interview with the director, the surveyor was informed that the medication belonged to a staff person. The medication was not being stored in a separate and locked location and was not out of reach of children.
