#### 1) Implementation of Policy

#### Findings:

General: Based on interview, the surveyor found that the director and staff were not following the center's policy on smoking which states "The designated area for smoking is out back of building out of sight of children. Employees are permitted to smoke only in this area and not in the presence of a child." Staff stated during interview that they smoked in the bathroom and back room in areas next to the nursery and toddler rooms.

#### 118 - Health, Safety, Comfort

922 KAR 2:110 - Section 4 (1) (I) Provide for the health, safety, and comfort of each child;

#### Findings:

General: Based on interview, the surveyor found that staff were smoking in the restroom, the back room and outside on the playground with the door to the playground open. These areas are beside the nursery and toddler areas.

#### 191 - Inaccessible Items

#### 922 KAR 2:120 - Section 3

- (7) The following shall be inaccessible to a child in care:
- (a) Toxic cleaning supplies, poisons, and insecticides;
- (b) Knives and sharp objects;
- (c) Matches, cigarettes, lighters, and flammable liquids;
- (d) Plastic bags;
- (e) Litter and rubbish;
- (f) Bar soap; and

## (g) Personal belongings of staff.

### 3) Matches, cigarettes, lighters, and flammable liquids

#### Findings:

General: Based on observation, the surveyor found that a pack of cigarettes and a lighter were being stored in a blue tote on a shelf in the back room accessible to the children.

#### 193 - Smoking Protocol

#### 922 KAR 2:120 - Section 3

(9) Smoking shall:

- (a) Be permitted in accordance with local ordinances;
- (b) Be allowed only in outside designated areas; and
- (c) Not be permitted in the presence of a child.

#### 2) Outdoor Designated Area

#### Findings:

General: Based on interview, the surveyor found that staff had been smoking in the bathroom and the back room which are not designated smoking areas. A review of the center's smoking policy found that the designated area for staff to smoke is outside at the back of the building out of the sight of the children.
