Findings: General: Based on interview and review of documentation, the child care center failed to maintain employee records in accordance with regulatory requirements. A review of staff files and an ECE-TRIS report failed to reveal 15 cabinet approved training hours for staff members with hire dates of 08/13/98, 08/10/10, and 08/18/98. Interview with staff in charge revealed the documentation was not available at the time of the survey.
