- (2) A child care staff member hired on or after April 1, 2018, shall:
- (a) Have completed the background checks required in accordance with this administrative regulation and been found to have no disqualifying offense prior to becoming a child care staff member; or
- (b)1. Have submitted to the background checks required in accordance with this administrative regulation;
- 2. Not be left unsupervised with a child in care pending the completion of the background checks in accordance with this administrative regulation; and
- 3. Be dismissed or relocated from the residence if the person is found to have a disqualifying background check result.

# Findings:

General: Based on observation, interview and review of documentation, the employee files for two staff members with a hire date of 6/11/2021 did not contain verification of employment eligibility as documented in the Kentucky Applicant Registry and Employment Screening (KARES) or verification that a Child Abuse and Neglect background check had been initiated. The employee files for staff members with hire dates of 9/28/2020 and 3/8/2021 did not contain verification of employment eligibility as documented in KARES or verification that a Criminal Records Check has been initiated. The staff member in charge acknowledged that the verification was not available at the time of the inspection. The aforementioned staff members were not observed working alone with children.
