<b>Findings:</b> General: Based on video observation and interviews, staff discovered a seventeen-month-old child alone in a classroom at 9:22 a.m. on 05/22/17. Video observation determined the toddler went out the door at approximately 9:19 a.m. and was found in the kitchen area which was located between two (2) classrooms and adjacent from the staff restroom and art area. The child was returned to the infant/toddler classroom where the two (2) responsible caregivers were not aware the child had left the classroom. The child was without supervision for three (3) minutes.
