(14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:

(a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;

(b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 1/2) hours of pediatric abusive head trauma training; and

(c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on Review of Documentation, three (3) staff members did not complete their fifteen (15) hours of cabinet-approved early care and education training hours during their completed training year. One staff hired on 9/28/78 completed 10 hours of training, one substitute staff hired on 6/1/14 completed no hours of training, and a substitute staff hired on 6/25/15 completed 1.50 hours of training. The ECE-TRIS system and the staff files were reviewed.

General: Based on Observation, two (2) window sills in the Preschool I Room contained some areas of chipped paint. The baseboards in the front school-age area contained some chipped paint.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on Observation, the hallway outside of the Preschool I Room contained scuff marks, tape residue, and it appeared unclean. The front school-age area contained some holes in the drywall behind the computer. There were some tears in the wallpaper behind the computer desk in the school-age room and some spills on the wallpaper behind the computer area.

Findings:

General: Based on Observation, the hall bathroom contained a plastic, wall-mounted, diaper changing table used for the toddlers and two (2) year-old children. The diaper changing table did not contain a pad.

- (6) Medication, including refrigerated medication, shall be:
- (a) Stored in a separate and locked place, out of the reach of a child;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the expiration date on the bottle has passed.

Findings:

General: Based on Observation, some Ex-lax tablets were located in the locked medicine cabinet in the kitchen, but they did not have a name on them. In addition, in the same location, some red tablets were observed, but the label was illegible and they did not have a name on them. The staff in charge indicated that those pills were for a bladder infection and they were for a staff member.
