General: Based on review of documentation, this regulatory requirement was not met. A review of staff files found that a staff person with a hire date of 6/25/15 had the results of a T.B, test read on 5/9/17. This exceeds the two year time-frame for a T.B. test.

# 410 - Training

## 922 KAR 2:090. Section 11. Staff Requirements.

(16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:

(a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;

(b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and

(c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

### Findings:

General: Based on review of documentation and ECE-TRIS records, this requirement was not met. A review of staff files found the following:

1) A staff person hired 6/25/15 had evidence of having completed only two (2) hours of annual training.

2) A staff person hired 9/28/78 did not have evidence of having completed fifteen (15) hours of annual training.

3) A staff person hired 9/1/74 had evidence of having only completed six and one-half (6 1/2) hours of annual training.

4) A staff person hired 9/28/78 did not have evidence of having completed fifteen (15) hours of annual training.

5) A staff person hired 3/12/88 did not have evidence of having completed fifteen (15) hours of annual training.

#### Programming

#### 420 - Program of Activities Followed

#### 922 KAR 2:120. Section 2. Child Care Services.

(4) The child-care center shall provide a daily planned program:

(a) Posted in writing in a conspicuous location with each age group and followed;

(b) Of activities that are individualized and developmentally appropriate for each child served;

(c) That provides experience to promote the individual child's physical, emotional, social, and intellectual growth and well-being; and

(d) Unless the child-care center is a before- or after-school program that operates part day or less, that offers a variety of creative activities including:

- 1. Art or music;
- 2. Math or numbers;
- 3. Dramatic play;
- 4. Stories and books;
- 5. Science or nature;
- 6. Block building or stacking;
- 7. Tactile or sensory activity;
- 8. Multi-cultural exposure;
- 9. Indoor or outdoor play in which a child makes use of both small and large muscles;
- 10. A balance of active and quiet play, including group and individual activity;
- 11. An opportunity for a child to:
- a. Have some free choice of activities;
- b. If desired, play apart from the group at times;

## Findings:

General: Based on observation, this regulatory requirement was not met. The planned program of activities posted in the 2's room at the time of the survey was dated for May 20-24, 2019.

#### 430 - Electronic Viewing/Listening Devices

#### 922 KAR 2:120. Section 2. Child Care Services.

(4) The child-care center shall provide a daily planned program:

(d) Unless the child-care center is a before- or after-school program that operates part day or less, that offers a variety of creative activities including the following:

12. Use of electronic viewing and listening devices if the:

- a. Material is appropriate to the child using the equipment;
- b. Material does not include any violence, adult content viewing, or inappropriate language;
- c. Viewing or individual listening is limited to two (2) hours per day;
- d. Viewing or listening is discussed with parents prior to viewing or listening; and
- e. Viewing or listening is designed as an educational tool.

(5) A child who does not wish to use the electronic devices during the planned program shall be offered other appropriate activities.

## Findings:

General: Based on observation, this regulatory requirement was not met. In the Pre-K room a television and several DVD's were observed. One of the DVD's observed was the movie Shrek which is rated PG. An interview with the teacher found that television is viewed no more than thirty (30) minutes a day.
