Through interview, it was confirmed that the staff (DOH: 5/30/17) did not have a completed child abuse/neglect check or a completed criminal records check.

Findings:

General: Based on observation, the surveyor found one (1) staff (DOH: 5/30/17) working alone with five (5) one-year-old children in the Younger Infants Classroom. It was confirmed through interview that the staff (DOH: 5/30/17) did not have a completed child abuse/neglect check or a criminal records check. The director reported submitting both the criminal records check and the child abuse/neglect check on 5/30/17. Proof of the submission of both of the checks could not be provided at the time of the survey.
