Findings:

General: Based on Review of Documentation and interview, this regulatory requirement was not met. A review of files found no evidence or results of a child abuse/neglect check (CAN) for someone identified as a parent volunteer. The staff person in charge stated that a CAN check was submitted for processing at the beginning of the school year (September 2015) and explained that the CAN check was returned to the facility with a request for additional documentation. The staff person in charge stated the CAN check with the additional documentation; however, has not yet received the results and could not provide evidence that the CAN check had been submitted.
