General: Based on observation and interview, the child care center did not maintain the minimum staff-to-child ratios. Observation revealed there were (7) children present with one (1) staff member. Interview with staff revealed the children were one-year-of age.

General: Based on observation, interview and review of documentation,

the child care center failed to comply with licensee responsibility regarding background checks. A visit was conducted on 05/03/2021, during the visit observation revealed the staff with a hire date of 03/31/2021 entered into the two-year-old classroom. The staff was left alone with nine (9) two and three-year-olds. Upon review of documentation, the staff in charge could not provide verification that the Criminal Records Check had been completed for the staff with a hire date of 03/31/2021.
