General: Based on Review of Documentation, it was found that the file for an employee hired on 7-10-15 contained a central registry check that had been stamped as being received by the Division of Child Care office on 7-24-15. The results section of the central registry check had not been completed, therefore it was unknown if the employee had a substantiation for abuse or neglect or not. The director stated that she had not noticed the lack of results on the form. This staff person was not observed to be alone with children and the director stated that she does not work alone.

The files and ECE-TRIS records for employees hired on 1-16-11, 1-29-13 and 1-29-13 contained evidence of only nine (9), twelve (12) and twelve (12) hours of training being completed within the last completed training year.
