General: Based on observation and interview, five (5) caregivers supervised twenty-four (24), one (1) to four (4) year old children in the gym, from 8:25 a.m. until 8:40 a.m. From 8:40 a.m. until 8:50 a.m., three (3) caregivers supervised sixteen (16), one (1) to three (3) year children in the gym. Interviews determined all children gathered to play together for at least thirty (30) minutes, three (3) times a day. Group size was not maintained.
