General: Based on observation during a tour of the kitchen, the surveyor found numerous chargers with extending cords in an unlocked cabinet drawer. The cords were within reach and accessible to the children. Additionally, the surveyor observed that following a diaper change, a staff person washed her hands at the kitchen sink. Through interview, the surveyor learned that the kitchen sink is not sanitized after each use; therefore, this creates the risk for cross contamination.
