The cords were within reach and accessible to the children. Additionally, the surveyor observed that following a diaper change, a staff person washed her hands at the kitchen sink. Through interview, the surveyor learned that the kitchen sink is not sanitized after each use; therefore, this creates the risk for cross contamination.
