- 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
- 2. Criminal records check required by KRS 199.896(19);
- 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and

- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

#### Findings:

General: Based on Review of Documentation, there was one (1) staff person with a hire date of 10/13/17 who is a college student and lives in Ohio when not in school. There were no results of a criminal records check from the state of Ohio on file at the facility and there was no documentation to verify that the application for the results of a criminal records check from Ohio had been submitted. At the time of the survey this staff person was not observed working alone with children. The staff person in charge also stated that this staff person has not been left alone with the children.

General: Based on Review of Documentation, there were two (2) staff (hire dates: 10/4/17 and 8/28/17) who did not have a high school diploma, GED or other qualifying documentation on file at the facility.

#### Findings:

General: Based on Review of Documentation presented at the time of the survey and ECE-TRIS records, found a staff person with a hire date of 1/1/10 did not have evidence of having completed fifteen (15) hours of training for the 2016-2017 training year. In addition, this same staff person completed pediatric abusive head trauma training 10/9/12 and did not renew the training until 10/26/17. There was an additional staff person with a hire date of 1/11/16 who had not completed pediatric abusive head trauma training. A staff person with a hire date of 9/10/05 had not completed fifteen (15) hours of training for the 2016-2017 training year. This staff person had also completed pediatric abusive head trauma training 10/9/12 and had not renewed the training.

General: Based on Review of Documentation, out of ten (10) children's files reviewed there were four (4) children whose enrollment information did not have a preferred hospital listed.
