922 KAR 2:090. Section 8. General.

(1) A licensee shall:

- (a) Be responsible for the operation of the child-care center pursuant to this administrative regulation, 922 KAR 2:120, and 922 KAR 2:280; and
- (b) Protect and assure the health, safety, and comfort of each child.

General: Based on review of video footage from an incident that occurred on 02/23/2021 and interviews, the surveyor found that a staff member grabbed the hood of a child's jacket and jerked the child back when the child tried to run from the staff member. As a result, the child's head and body were also jerked backwards. Therefore, the health, safety, and comfort of the child were compromised.

922 KAR 2:410E. Emergency Regulation.

Due to the current declared public health emergency caused by the Novel Coronavirus Disease (COVID-19), licensed child care centers must operate under Centers for Disease Control and Prevention and public health guidelines, as mandated by 922 KAR 2:410E, to prevent the spread of COVID-19.

Findings:

General: Based on review of documentation, the surveyor found the following:

- 1. A staff's (DOH: 02/03/21) file did not contain a completed Child Abuse/Neglect Background Check or Criminal Records Background Check. During interview, staff-in-charge stated that the staff member has not worked alone with children. The surveyor did not observe the staff member working alone with children.
- 2. A staff's (DOH: 03/31/20) file did not contain a completed Criminal Records Background Check. The staff file contained an original Child Abuse/Neglect Background Check only dated for 03/31/20. The surveyor observed the staff member to be working with children in the same classroom as another staff member who also did not have a completed Criminal Records Background Check.
- 3. A staff's (DOH: 12/21/20) file did not contain a completed Criminal Records Background Check. The staff file contained an original Child Abuse/Neglect Background Check only dated for 12/29/20. During interview, staff-in-charge stated that they were unaware if the staff member has worked alone with children. The surveyor did not observe the staff member working alone with children.
- 4. A staff's (DOH: 12/14/20) file did not contain a completed Criminal Records Background Check. The staff file contained an original Child Abuse/Neglect Background Check only dated for 12/29/20. The surveyor observed the staff member to be working with children in the same classroom as another staff member who also did not have a completed Criminal Records Background Check.
- 5. A staff's (DOH: 02/08/21) file did not contain a completed Criminal Records Background Check. The staff file contained an original Child Abuse/Neglect Background Check only dated for 02/09/21. During interview, staff-in-charge stated that they were unaware if the staff member has worked alone with children. The surveyor did not observe the staff member working alone with children.
- 6. A staff's (DOH: 08/28/20) file did not contain a completed Criminal Records Background Check. The staff file contained an original Child Abuse/Neglect Background Check only dated for 09/09/20. The surveyor observed the staff member to be working alone with children during the visit on 03/02/2021.

Based on review of the Kentucky National Background Check Service, all of the staff members mentioned did not have completed background checks.
