**Findings:**

General: Based on Observation, and interview, the child care center failed to maintain an outdoor play are in accordance with regulatory requirements. Observation of the left playground fence revealed five (5) areas where the bottom portion of the wire fencing was not in good condition. Observation of the right playground fence revealed four (4) areas where the bottom portion of the wire fencing was not in good condition. Interview with the staff in charge revealed the deficiency is in the process of being addressed.
