General: Based on Review of Documentation, it was found that the files for eleven (11) eligible employees did not contain evidence of an annual evaluation being completed.

922 KAR 2:090. Section 6. License Issuance.

- (5) An individual described in subsection (4) of this section shall:(a) Submit to background checks described in paragraph (b) of this subsection;
- (b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:
- 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
- 2. Criminal records check required by KRS 199.896(19);
- 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
- 4. An address check of the Sex Offender Registry; and
- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, it was found that the file for an employee hired on 4-1-17 did not contain the results of a completed central registry check despite a request being submitted. This employee has been employed longer than the allowed ninety (90) days. This employee reportedly has not worked alone with children.



315 - Educational Requirements

- (1) Child-care center staff:
 - (a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:
 - 1. High school diploma:
 - 2. GED or qualifying documentation from a comparable educational entity; or
 - 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

Findings:

General: Based on Review of Documentation, it was found that the files for employees hired on 4-1-16 and 5-15-17 did not contain evidence of a high school diploma, GED or Commonwealth Childcare Credential.

320 - TB Verification Not In Compliance

922 KAR 2:110. Section 5. Staff Requirements.

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
- 1. A statement from a health professional that the individual is free of active tuberculosis; or
- 2. A copy of negative tuberculin results.

Findings:

General: Based on Review of Documentation, it was found that the files for employees hired on 4-1-16, 6-1-17, 9-1-17 and 5-15-17 did not contain evidence of a TB skin test or screening. In addition, it was found that the files for employees hired on 1-1-17 and 2-15-17 contained the results of TB skin tests that were read on 1-16-17 and 2-23-17 respectively. These dates are not prior to the date of hire as required.

340 - Training Not In Compliance

922 KAR 2:110. Section 5. Staff Requirements.

- (14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 $\frac{1}{2}$) hours of pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on Review of Documentation, it was found that 1) the ECE-TRIS record and file for an employee hired on 5-22-16 contained evidence of only two (2) hours of additional training being completed during the first year of employment; 2) the ECE-TRIS record and file for an employee hired on 7-1-15 contained evidence of only four (4) hours of training being completed during the last completed training year; 3) the ECE-TRIS record and file for an employee hired on 4-1-16 contained evidence of zero (0) hours of training being completed during the first year of employment; 4) the ECE-TRIS records and files for employees hired on 11-1-16 and 3-22-16 did not contain evidence of Pediatric Abusive Head Trauma training being completed; 5) the ECE-TRIS records and files for employees hired on 11-1-16, 10-20-17, 6-1-17, 9-11-17, 2-15-17 and 1-1-17 did not contain evidence of the six-hour cabinet-approved orientation training being completed; 6) the ECE-TRIS record and file for an employee hired on 4-1-17 contained evidence of the six-hour cabinet-approved orientation training being completed on 10-10-17. This date is not within the ninety (90) day timeframe required by the regulation.
