Findings:

General: Based on observation, it was found that a staff member's cell phone was sitting on a table in the preschool classroom. Therefore, this cell phone was accessible to the children in this classroom.

580 - Floors, Walls, Ceilings Not In Compliance

922 KAR 2:120. Section 4. Premises Requirements.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on observation, the following was found:

- 1.) There was a cracked floor tile in the two-year-old classroom. This tile was located by a door in the classroom (not an entrance/exit door). It was also found in this classroom, that there was some areas on the wall that contained crayon marks and some scuff marks/chipped paint.
- 2.) In the one-year-old classroom, there was an area on the wall located under the window that had areas of missing/chipped paint. This left other colors of paint that were exposed.
- 3.) In the boys bathroom, the wall was damaged and in disrepair. The staff in charge reported that someone had come out to the facility to look at this area and no leak was found, so the wall is going to have to be removed and repaired to fix the damage.
