# Findings:

General: Based on interview and review of documentation, the employee file for a staff member with a hire date of 9/30/20 did not contain a high school diploma, GED or qualifying documentation from a comparable educational entity; or Commonwealth Child Care Credential. Interview with the staff member in charge revealed the documentation was not available at the time of the inspection.

(a) Six (6) hours of cabinet-approved orientation completed within the first three (3) months of employment in a child care program;

(b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1  $\frac{1}{2}$ ) hours of cabinet-approved pediatric abusive head trauma training; and

(c) Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

(17) A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.

#### Findings:

410 - Training

General: Based on interview and review of documentation, the staff files for two staff members with a hire date of 10/15/20 did not contain verification that the staff members had completed six (6) hours of cabinet approved orientation training. Review of ECE-Tris records failed to verify the aforementioned training. Interview with the staff member in charge revealed that the staff members had not completed the training.

General: Based on review of documentation, there was not a current daily schedule of activities, to include the date and times of activities to be conducted with children, posted in the Fours Room, Crawlers Room, and Threes Room.

#### 1260 - Emergency Regulation

#### 922 KAR 2:410E. Emergency Regulation.

Due to the current declared public health emergency caused by the Novel Coronavirus Disease (COVID-19), licensed child care centers must operate under Centers for Disease Control and Prevention and public health guidelines, as mandated by 922 KAR 2:410E, to prevent the spread of COVID-19.

#### Findings:

General: Based on observation, interview and review of documentation, the employee file for a staff member with a rehire date of 11/11/2020 did not contain a Criminal Abuse and Neglect background check or a Criminal Records Check. Additionally, the aforementioned staff member was not listed with an "active" status on the center's KARES roster. Interview with the staff member in charge revealed that the background checks were not initiated upon the staff member being rehired, nor was the staff member moved to an "active" status in the KARES database. The aforementioned staff member was observed to work alone with children. The employee file for a staff member with a hire date of 1/18/21 did not contain verification that a CAN background check had been initiated. The employee file for a staff member with a hire date of 12/9/19 did not contain verification the a CRC background check had been initiated. The aforementioned staff members were not listed on the center's KARES database. Interview with the staff member in charge revealed that the background check had been initiated. The aforementioned staff members were not bised on the center's KARES database. Interview with the staff member in charge revealed that the background check had been initiated. The aforementioned staff members were not observed to work alone with children.
