Findings:

General: Based on Observation, there were two (2) white dishpans sitting on the deck where the water slide is located on the playground. Interviews with staff found that after a child goes down the slide and gets out of the pool of water they climb back on the deck and rinse their feet off in the the dishpans that are filled with water. The dishpans are then emptied and refilled after each class finishes using the water slide. This is not a sanitary means of cleaning off the feet.

- 3. The animal is certified as vaccinated against rabies; or
- (b) Except in accordance with subsection (3) of this section.

Findings:

General: Based on Observation, there was a fish in the Lemurs classroom. In an interview with the Director it was found that written parental consent for children to be in the presence of the fish had not been obtained.

- (3) An animal that is considered undomesticated, wild, or exotic shall not be allowed at a child-care center unless the animal is:
