General: Based on observation, the surveyor found a toilet plunger and holder beside the commode used by the three and four-year-old children. The plunger and holder were within reach and accessible to the children.

Findings:

General: Based on review of documentation, the surveyor found no verification of a staff's (DOH: 9/30/19) High School Diploma, GED or Commonwealth Child Care Credential. Through interview, the surveyor learned that the staff's verification of education was not available at the time of the renewal survey.

410 - Training Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of documentation and ECE-TRIS, the surveyor found verification of only eleven and one-half (11 ½) hours of cabinet-approved early care and education annual training for a staff (DOH: 11/27/17).

- (2) Except in accordance with subsection (3) of this section or Section 2(2)(c) of this administrative regulation, an infant or toddler under twenty-four (24) months of age shall not participate in an activity with an older child for no more than one (1) hour per day.
- (3) If a toddler is developmentally appropriate for a transition to a preschool age group, a toddler may participate in an activity with an older child for more than one (1) hour per day if:
- (a) Space for the toddler is available in the preschool-age group;
- (b) The staff-to-child ratios and group sizes are maintained based on the age of the youngest child;
- (c) The center has a procedure for listing a transitioning toddler on attendance records, including a specific day and time the toddler is with either age group; and
- (d) The child care center has obtained the signature and approval of the toddler's parent on the toddler's transition plan.

Findings:

General: Based on review of documentation, the surveyor found that staff and parents completed transition plans for children transitioning into classes with older children. The surveyor did not find the specific dates and times that the children were with either age group.

495 - Bedding/Toys in Crib Not In Compliance

- (3) Rest time shall include adequate space specified by the child's age as follows:
- (a) For an infant:
- 3. No loose bedding, such as a bumper or a blanket; and
- 4. No toys or other items except the infant's pacifier;

Findings:

General: Based on observation during a tour of the Nursery, the surveyor found a swaddled child sleeping in a crib. A toy was on the crib mattress beside the child.

Findings:

General: Based on observation, the surveyor found that the hard vinyl-type baseboard was loose and protruding outward located on the steps leading to a restroom used by the children.

645 - Sink Not In Compliance

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (3) A sink shall be:
- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;
- (f) Equipped with an easily cleanable waste receptacle; and
- (g) Immediately adjacent to a changing area used for infants and toddlers.

Findings:

General: Based on observation, the surveyor found that the water temperature measured at sixty-six (66) degrees Fahrenheit at the sink in the restroom used by the school-age
