General: Based on observation, interview and review of documentation, two (2) caregivers supervised eleven (11) children at approximately 8:40 a.m. until 8:45 a.m. and supervised thirteen (13), children at approximately 8:45 a.m. until 9:10 a.m. in the toddlers' room. The age of the youngest child was a four-month-old.

General: Based on review of documentation, a caregiver hired 01/29/18, had a TB skin test dated 09/08/17. A caregiver hired 12/07/17, had a TB skin test dated 11/29/17.

General: Based on observation and interview, a staff member's coat hung on the back of the chair, accessible to the preschool children. Interview revealed this was prevously discussed during the center's staff meetings.

General: Based on observation, three (3) toddler children did not wash their hands before and after they ate breakfast.
