- 2. GED or qualifying documentation from a comparable educational entity; or
- 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

### Findings:

General: Based on review of documentation presented, the surveyor found:

- 1. A staff's (DOH: 06/21/2021) file presented for review did not contain a high school diploma, GED, or Commonwealth Child Care Credential.
- 2. A staff's (DOH: 05/24/2021) file presented for review did not contain a high school diploma, GED, or Commonwealth Child Care Credential.

During interview, staff confirmed the documents were not in the staff's files.



405 - TB Verification Not In Compliance

# 922 KAR 2:090. Section 11. Staff Requirements.

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
- 1. A statement from a health professional that the individual is free of active tuberculosis; or
- 2. A copy of negative tuberculin results.

#### Findings:

General: Based on review of documentation presented, the surveyor found:

- 1. A staff's (DOH: 05/24/2021) file did not contain a statement from a health professional that the individual is free of active tuberculosis or a copy of negative tuberculin result. Staff confirmed through interview that the staff's file did not contain a negative tuberculin result or a copy of a negative tuberculin result.
- 2. A staff's (DOH: 04/27/2018) file did not contain a current statement from a health professional that the individual is free of active tuberculosis or a copy of negative tuberculin result. The most current negative tuberculin result in the staff's file was dated 04/06/2018; therefore, the result was not updated every two (2) years. Staff confirmed through interview that the staff's file contained a negative tuberculin result that was not completed within the last two (2) years.

410 - CPR/First Aid Coverage Not In Compliance

### 922 KAR 2:090. Section 11. Staff Requirements.

- (3) For a child-care center licensed for infant, toddler, or preschool-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:
- (a) Infant and child cardiopulmonary resuscitation; and
- (b) Infant and child first aid.
- (4) For a child-care center licensed for school-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:
- (a) Adult cardiopulmonary resuscitation; and
- (b) First aid.
- (5) Cardiopulmonary resuscitation (CPR) and first aid training shall be in addition to the fifteen (15) clock hours requirement in subsection (16) of this section.

#### Findings:

General: Based on review of documentation presented, the surveyor found:

- 1. There were no staff on duty and present with the children who are certified by a cabinet-approved training agency in infant and child cardiopulmonary resuscitation or infant and child first aid.
- 2. There were no staff on duty and present for school-age children who are certified by a cabinet- approved training agency in adult cardiopulmonary resuscitation and first aid.

During interview, staff were aware that there were no staff present at child-care center who were certified in first aid or CPR.

420 - Adequate Substitute(s) Not In Compliance

## 922 KAR 2:090. Section 11. Staff Requirements.

- (6) Child-care centers shall have available in case of need:
- (a) One (1) qualified substitute staff person for a Type II child-care center; or
- (b) Two (2) qualified substitute staff persons for a Type I child-care center.
- (7) Each qualified substitute staff person shall:
- (a) Meet the staff requirements of this administrative regulation; and
- (b) Provide the required documentation to verify compliance with this administrative regulation.

#### Findings:

General: Based on review of documentation presented, a staff (DOH: 6/21/2021) identified as a substitute does not meet the staff requirements of this administrative regulation. The staff's proof of educational qualifications were not in the staff's file.



435 - Training Not In Compliance

#### 922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation completed within the first three (3) months of employment in a child-care program;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1  $\frac{1}{2}$ ) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.
- (17) A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.

#### Findings:

General: Based on review of documentation provided and a review of ECE-TRIS, the surveyor found the following:

- 1. A staff file (DOH: 05/02/2018) did not contain documentation of the staff's completion of the fifteen (15) hours of cabinet-approved early care and education training for a time period of 07/01/2020 through 06/30/2021. A review of ECE-TRIS revealed that the staff obtained zero (0) of the required hours of annual training.
- 2. A staff member (DOH: 04/27/2018) completed the one and one-half (1 ½) hours of pediatric abusive head trauma training on 11/18/2015. A review of the staff member's file and ECE-TRIS found no additional PAHT training; therefore, the PAHT training was not completed every five (5) years.
- 3. A staff member (DOH: 07/21/2020) obtained the six (6) hours of cabinet-approved orientation on 04/28/2021; therefore, the training was not obtained during the staff's first three (3) months of employment.
- 4. A staff member (DOH: 07/01/2020) obtained the six (6) hours of cabinet-approved orientation on 05/25/2021; therefore, the training was not obtained during the staff's first three (3) months of employment.
- 5. A staff member (DOH: 08/28/2020) obtained the six (6) hours of cabinet-approved orientation on 05/24/2021; therefore, the training was not obtained during the staff's first three (3) months of employment.
- 6. A staff member (DOH: 06/28/2021) did not obtain the six (6) hours of cabinet-approved orientation training within the first three (3) months of employment.
- 7. A staff member (DOH: 06/21/2021) did not obtain the six (6) hours of cabinet-approved orientation training within the first three (3) months of employment.
- 8. A staff member (DOH: 05/24/2021) did not obtain the six (6) hours of cabinet-approved orientation training within the first three (3) months of employment.

During interview, staff stated they were not aware that the staff had not completed their trainings.

General: Based on review of documentation presented, the surveyor found the following:

- 1. A child's (DOE: 05/11/2018) did not contain contact information to enable a person in charge to contact their preferred hospital.
- 2. A child's (DOE: 09/24/2020) did not contain contact information to enable a person in charge to contact their preferred hospital. The file did not contain the name of each person who is designated in writing to pick-up the child. The file did not contain the name and phone number of each person to be contacted in an emergency involving or impacting the child.
- 3. A child's (DOE: 07/27/2020) did not contain contact information to enable a person in charge to contact their preferred hospital.
- 4. A child's (DOE: 07/27/2020) did not contain contact information to enable a person in charge to contact their preferred hospital.
- 5. A child's (DOE: 03/23/2018) did not contain contact information to enable a person in charge to contact their preferred hospital.
- 6. A child's (DOE: 06/27/2018) did not contain contact information to enable a person in charge to contact their preferred hospital.
