<b>Findings:</b>	
<p>General: Based on observation, this regulatory requirement was not met. The boy's and girl's restrooms (located in the hallway) contained a bottle of Chem San 10 disinfectant spray cleaner under the handwashing sinks. The cleaners indicated to keep out of reach of a child. The bottles were located under the sinks in unlocked cabinets. The staff in charge moved both cleaners to an area that was not accessible to the children during the renewal survey.</p>

- (c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint, poisonous material, and flaking or chalking paint; and**
- (d) Be designed to guard against entrapment or situations that may cause strangulation.**

General: Based on observation, this regulatory requirement was not met. The mini-refrigerator located in the After-Care Room contained brown spills on the inside walls and on the bottom shelf.

**(1) A child-care center shall maintain:**

- (a) A current immunization certificate for each child in care within thirty (30) days of the child's enrollment, unless an attending physician or the child's parent objects to the immunization of the child pursuant to KRS 214.036;**

**Findings:**

General: Based on observation and review of documentation, this regulatory requirement was not met. A child enrolled on 8/17/2020, did not have an immunization certificate on file.

**922 KAR 2:090. Section 9. Records.**

**(1) A child-care center shall maintain:**

**(b) A written record for each child:**

- 1. Completed and signed by the child's parent;**
- 2. Retained on file on the first day the child attends the child-care center; and**
- 3. To contain:**
  - a. Identifying information about the child, which includes, at a minimum, the child's name, address, and date of birth;**
  - b. Contact information to enable a person in charge to contact the child's:**
    - (i) Parent at the parent's home or place of employment;**
    - (ii) Family physician; and**
    - (iii) Preferred hospital;**
  - c. The name of each person who is designated in writing to pick-up the child;**
  - d. The child's general health status and medical history including, if applicable:**
    - (i) Allergies;**
    - (ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and**
    - (iii) Permission from the parent for third-party professional services in the child-care center;**
  - e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;**
  - f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;**

**Findings:**

General: Based on observation and review of documentation, this regulatory requirement was not met. A child enrolled on 8/17/2020, did not have a preferred hospital listed on their enrollment paperwork. The paperwork listed N/A in the area for the preferred hospital.
