922 KAR 2:090. Section 11. Staff Requirements.

(1) Child-care center staff:

- (a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:**
1. High school diploma;
 2. GED or qualifying documentation from a comparable educational entity; or
 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

Findings:

General: Based on review of documentation and interview, this regulatory requirement was not met. One (1) staff person (hire date: 6/27/22) did not have educational documentation on file. The staff person in charge stated that this staff person is no longer employed. Her last day was identified as 8/11/22.

405 - TB Verification

922 KAR 2:090. Section 11. Staff Requirements.

(1) Child-care center staff:

- (b) Shall provide, prior to employment and every two (2) years thereafter:**
1. A statement from a health professional that the individual is free of active tuberculosis; or
 2. A copy of negative tuberculin results.

Findings:

General: Based on review of documentation and interview, this regulatory requirement was not met. One (1) staff person (hire date: 6/27/22) had a T.B. screening form in her file; however, the form was blank. The staff person in charge stated that this staff person is no longer employed. Her last day was identified as 8/11/22.

545 - Two Hour Limit - Rest Time	Not In Compliance
<div>922 KAR 2:120. Section 6. Sleeping and Napping Requirements. (4) Rest time shall not exceed two (2) hours for a preschool-age child unless the child is attending the child-care center during nontraditional hours.</div>	
Findings: General: Based on review of documentation, this regulatory requirement was not met. The surveyor reviewed video footage from 8/17/22 with the staff person in charge and found that rest time in Room #5 lasted from approximately 11:45AM - 2:20PM; therefore, it exceeded the two hour limit.	
550 - Rest Period - Alternate Activity	Not In Compliance
<div>922 KAR 2:120. Section 6. Sleeping and Napping Requirements. (5) A child who does not sleep shall be permitted to play quietly and shall be visually supervised.</div>	
Findings: General: Based on review of documentation, this regulatory requirement was not met. The surveyor reviewed video footage from 8/17/22 with the staff person in charge and found that several children did not go to sleep during rest time in Room #5 and Room #8, but they were not allowed to play quietly.
