- (e) Obtained from a source that is in compliance with the Department of Public Health's food safety standards and permits, established in KRS Chapter 217;**

Findings:

General: Based on interview and review of documentation, the surveyor found that the child-care center was preparing foods in a staff person's home and the food was transported by private vehicle to the center to serve to the children.

During interview, staff stated that she would not have food prepared at her home and transport to the child-care center.
