- 1.) One electrical outlet in the One-year-old classroom was not protected.
- 2.) Children's coats were stored on hooks in the Three-year-old classroom; the coats overlapped. This method of storage promotes the spread of germs and bacteria

- 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

General: Based on review of documentation, staff members hired 3/3/2020 and 5/20/2021, did not have documentation of educational qualifications in their personnel files.



405 - TB Verification Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
- 1. A statement from a health professional that the individual is free of active tuberculosis; or
- 2. A copy of negative tuberculin results.

435 - Training

General: Based on review of documentation, staff members hired 2/18/2019 and 9/18/2017, had a negative tuberculin record that exceeded two years and was no longer current.

- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1 $\frac{1}{2}$) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.
- (17) A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.

Findings:

General: Based on review of documentation, staff members hired 2/18/19, 3/3/20, 11/16/18, 10/29/18, 1/14/19, and 1/28/19, did not complete 15 hours of Cabinet- approved early care and education training for the July 1, 2020 – June 30, 2021 year of training. Additionally, staff members hired 5/20/2021 and 3/29/2021, have not yet completed orientation training, these staff members have been employed longer than 90 days. A review of ECE-TRIS supports these findings.

Programming Not In Compliance

540 - Bedding/Toys in Crib

922 KAR 2:120. Section 6. Sleeping and Napping Requirements.

- (3) Rest time shall occur in an adequate space according to the child's age as follows:
- (a) For an infant:
- 3. No bedding other than a clean tight-fitted sheet; and
- 4. No toys or other items except the infant's pacifier;

Findings:

General: Based on observation, four cribs in the Infant classroom had sheets that were loosely fitted on the mattress; this poses a suffocation hazard. Additionally, four infants were observed sleeping with blankets.

565 - Inaccessible Items

- (7) The following shall be inaccessible to a child in care:
- (a) Toxic cleaning supplies, poisons, and insecticides;

625 - Floors, Walls, Ceilings

General: Based on observation, several gallons of paint were stored in the hallway of the Two-year-old classrooms; the label on the paint read, "Keep out of reach of children".

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on observation, the following was found:

- 1.) A ceiling tile appeared to be water-stained within the School-age classroom.
- 2.) There was a crack on the wall near the block section of the Four-to-Five-year-old classroom. Additionally, there were several areas of chipped drywall in the Library and Art section of this classroom.

- 2. Diaper cream, sunscreen, or toothpaste. Diaper cream, sunscreen, or toothpaste shall be inaccessible to a child;
- 3. An epinephrine auto-injector. A licensed child-care center shall comply with KRS 199.8951 and 311.646, including:
- a. An epinephrine auto-injector shall be inaccessible to a child;
- b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
 - c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
- d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 13(1)(b) if an epinephrine auto-injector is administered to a child; or
- 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

General: Based on observation, two tubes of diaper cream were not labeled with a child's name, within the Infant classroom.

General: Based on observation, the cribs in the Infant classroom were placed side by side, without 12 inches of space between them.

- (1) All toys and furniture contacted by a child shall be:
- (a) Kept clean and in good repair; and
- (b) Free of peeling, flaking, or chalking paint.

Findings:

General: Based on observation, tape residue had started to accumulate dirt and grime on the block shelf within the One-year-old classroom.

General: Based on review of documentation, two children enrolled 12/22/17 and 8/29/18, did not have emergency consent in their enrollment information.

- (h) A written record of quarterly practiced earthquake drills and tornado drills detailing the date, time, and children who participated in accordance with 922 KAR 2:120, Section 3;
- (i) A written record of practiced fire drills conducted monthly detailing the date, time, and children who participated in accordance with 922 KAR 2:120, Section 3;

Findings:

General: Based on review of documentation, the Fire, Tornado, and Earthquake drill documentation did not list the names of the children who had participated.

1295 - Confidentiality/Maintenance/Access

General: Based on observation and review of documentation, documents listing children's allergies was posted on the wall in the Three-year-old classroom; the document was viewable for public inspection.

General: Based on review of documentation, the lesson plan in the Infant classroom did not contain a date; the surveyor was unable to determine whether the posted plan was current
