General: Based on review of documentation, it was found that two staff members did not have evidence of an annual evaluation on file at the facility. The dates of hire for these staff are 11/02/2018 and 11/12/2018.

Findinas:

General: Based on observation, the following was found:

- 1.) During a tour of the classrooms, it was observed that there were chairs stacked on tables and a desk attached to the wall in the one's, two's, and preschool classroom. This practice posed a risk to the children in care.
- 2.) In the girl's hallway bathroom, in front of the two's and preschool classroom, the paper towels were being stored on the sink countertop. This is not a sanitary practice.
- 3.) There was an uncovered electrical outlet in the hallway between the infant and one-year-old classroom.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 $\frac{1}{2}$) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of documentation, the following was found:

- 1.) One staff member did not have the required Pediatric Abusive Head Trauma training. The date of hire for this staff is 11/02/2018.
- 2.) One staff member did not complete orientation training within the required timeframe. The staff was hired in November of 2018 and did not complete the training until June of 2019

A review of ECE-TRIS confirmed these findings.

- 2.) There was an area of missing paint in the beginning of the hallway leading to the playground.

Findings:

General: Based on observation, it was found that the girls bathroom in the hallway located in front of the two's and preschool classroom, did not contain any toilet paper.

1. In the infant classroom.

2. In the hallway bathroom, located in the hall leading to the outside playground. The diapering changing steps were located on a mirror that was positioned in a way that the staff person changing the diaper would have their back to the procedures.
