922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation completed within the first three (3) months of employment in a child care program;
 - (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
 - (c) Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.
- (17) A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.

Findings:

General: Based on review of documentation, it was found that one staff person did not complete orientation within the required ninety-day timeframe. The staff member was hired on 09/16/2020, and did not complete orientation until 02/03/2021. A review of ECE-TRIS confirmed these findings.

Findings:

General: Based on observation, there was a roll of trash bags accessible to the children at the facility. These trash bags were located in the staff bathroom; however, the bathroom door was unlocked and open during the inspection.

580 - Floors, Walls, Ceilings

- (9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.**

Findings:

General: Based on observation, the following was found:

- 1.) In the one- and two-year-old classroom, there was large ceiling vent that was very dusty.
- 2.) In the one-year-old classroom, there was a crack in the wall underneath one of the windows.

General: Based on observation, it was found that there were toys on the diaper changing pad in the one-year-old room. These items are not needed for diaper changing.
