520 - Inaccessible Items

922 KAR 2:120. Section 3. General Requirements.

(7) The following shall be inaccessible to a child in care:

(a) Toxic cleaning supplies, poisons, and insecticides;

(b) Matches, cigarettes, lighters, and flammable liquids; and

(c) Personal belongings and medications of staff.

Findings:

General: Based on observation, the surveyor found the following:

1. A Victor glue trap placed by the door in the restroom located beside of Nursery II.

2. A Victor glue trap placed in the corner of the room in the One Year Old Classroom located next to the Two Year Old Classroom.

3. A Victor glue trap placed by the door in the restroom located by Nursery I.

4. A Victor glue trap placed by the door in the restroom located in the School age Classroom.

5. Two (2) garden hoses had been placed on the ground beside two (2) separate exit doors. During interview with staff-in-charge, the surveyor learned that the children use one (1) of the exit doors to go to the playground; however, the other exit door was not used by the child-care center.

The items mentioned were observed to be accessible to the children.

540 - Premises Requirements

922 KAR 2:120. Section 4. Premises Requirements.

(1) The premises shall be:

(a) Suitable for the purpose intended;

(b) Kept clean and in good repair;

Findings:

General: Based on observation, the surveyor found the following:

1. One (1) square rug that contained stains and one (1) blue square rug that contained debris in the One Year Old Classroom located by Nursery II; therefore, the rugs were not kept clean.

2. A black rug that contained debris located in front of an exit door in the Three Year Old Classroom; therefore, the rug was not kept clean.

3. A square ABC rug that contained stains and debris in the One Year Old Classroom located next to the Three Year Old Classroom; therefore, the rug was not kept clean.

4. A square red and yellow rug that contained debris in the Two Year Old Classroom; therefore, the rug was not kept clean.

5. A round cream rug that contained debris in the One Year Old Classroom located beside of the Two Year Old Classroom; therefore, the rug was not kept clean.

6. A gray square rug that contained stains in Nursery I; therefore, the rug was not kept clean.

7. One (1) ABC square rug and one (1) car square rug that contained debris in the Preschool Classroom; therefore, the rugs were not kept clean.

8. A large yellow square rug that contained stains in the Preschool Classroom; therefore, the rug was not kept clean.

9. One (1) blue half circle rug and one (1) black square rug that contained debris in the School age Classroom; therefore the rugs were not kept clean.

10. The sink in the restroom located in the School Age Classroom contained stains around the faucet; therefore, the sink was not kept clean.

1. The hot water in the restroom located in the Three Year Old Classroom measured at a temperature of 125 degrees Fahrenheit; therefore, the sink was not equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit.

2. The hot water in the restroom located in the School Age Classroom measured at a temperature of 130 degrees Fahrenheit; therefore, the sink was not equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit.

3. The rim around the toilet seat hinges and the base of the toilet contained dried urine in the restroom located in the Preschool Classroom; therefore, the toilet was not kept in clean condition. **Hygienic Practices**

The diaper changing pad contained stains and the diaper changing table underneath the diaper changing pad contained debris in the following classrooms: the One Year Old Classroom located by Nursery II, the Three Year Old Classroom, the One Year Old Classroom located next to the Three Year Old Classroom, the Two Year Old Classroom, and the One Year Old Classroom located next to the Two Year Old Classroom; therefore, the diaper changing surfaces were not clean.

2. The diaper changing pad located in Nursery I contained a small tear.

3. The diaper changing table underneath the diaper changing pad contained debris in Nursery I; therefore, the diaper changing surface was not clean.
