General: Based on observation, at approximately 7:15 am, a child was observed standing in the space between the two (2) sets of entry doors of the school. There was no adult near the child. After approximately three (3) minutes an adult was observed entering the entry way and allowing the child to go inside. When the staff member was asked if the facility was just opening, she stated that the facility had already been open, but the child was watching the doors while the staff member went to the restroom. The staff member further stated that they were short staffed.
