(b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 1/2) hours of cabinet-approved pediatric abusive head trauma training; and

(c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

General: Based on review of documentation and ECE-TRIS, the surveyor found that a staff (DOH: 06/13/16) had obtained only twelve (12) hours of cabinet-approved early care and education annual training from 6/13/2018 through 6/12/2019.

520 - Inaccessible Items Not In Compliance

922 KAR 2:120. Section 3. General Requirements.

- (7) The following shall be inaccessible to a child in care:
- (a) Toxic cleaning supplies, poisons, and insecticides;
- (b) Matches, cigarettes, lighters, and flammable liquids; and
- (c) Personal belongings and medications of staff.

Findings:

General: Based on observation, the surveyor found liquid hand soap placed in all restrooms that stated on the label "Keep Out of Reach of Children"; thus, the liquid hand soap was accessible to the children. During interview, the staff in charge stated that the containers are re-filled from another container; however when the staff in charge pulled the container, it was labeled "Keep Out of Reach of Children" as well. The staff in charge stated she was not aware that the liquid soap stated that on the label and they will begin putting the soap out of reach of the children.

645 - Sink Not In Compliance

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (3) A sink shall be:
- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;
- (f) Equipped with an easily cleanable waste receptacle; and
- (g) Immediately adjacent to a changing area used for infants and toddlers.

Findings:

General: Based on observation, the surveyor found that the hot water temperature of the sink, located in Classroom A, measured seventy-eight (78) degrees Fahrenheit. The surveyor found that the hot water temperature in the sink located in the lunchroom bathroom used by students measured eighty-two (82) degrees Fahrenheit. Therefore the water temperature of the sinks did not fall within the required minimum ninety (90) degrees Fahrenheit and maximum one hundred and twenty (120) degrees Fahrenheit. Upon interview, the staff in charge stated that she wasn't aware the temperature was too low and a plumber would be called to correct the problem.
