General: Based on observation, the surveyor found the following:

1. The toilet seat was loose and not secured to the toilet in the girls' restroom located in Preschool B Classroom.
 2. The based of the toilet contained a yellow dried substance that appeared to be urine in the boys' restroom located in Preschool B Classroom.
- Therefore, the toilets were not kept clean or in good repair.
