(16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following: (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment; (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.</p>	
Findings:	
General: Based on review of documentation presented to the surveyor for review, the surveyor discovered that a staff person (DOH 3/1/19) had not completed Pediatric Abusive Head Trauma training. Therefore, the training requirement has not been met.

- (7) The following shall be inaccessible to a child in care:**
 - (a) Toxic cleaning supplies, poisons, and insecticides;**
 - (b) Matches, cigarettes, lighters, and flammable liquids; and**
 - (c) Personal belongings and medications of staff.**

Findings:

General: Based on observation during a tour of the Nursery Classroom's restroom, the surveyor discovered the following:

- 1. There was a bottle of disinfectant spray in a unlocked cabinet. Therefore, the disinfectant spray was accessible to the children.
- 2. A bleach bottle had been placed by the sink in the restroom. Therefore, bleach bottle was accessible to the children.

Staff reported that the children do not use the restroom; however, the restroom door was propped open leaving the items accessible to the children.

 - (b) Promptly refrigerated;**
 - (c) Covered while not in use; and**

Findings:

General: Based on observation during a tour of the Nursery Classroom, the surveyor discovered an uncovered bottle located on a shelf. Staff reported that the child's parent brought the bottle in without a lid.

- (1) A child-care center shall maintain:**
 - (b) A written record for each child:**
 - 1. Completed and signed by the child's parent;**
 - 2. Retained on file on the first day the child attends the child-care center; and**
 - 3. To contain:**
 - a. Identifying information about the child, which includes, at a minimum, the child's name, address, and date of birth;**
 - b. Contact information to enable a person in charge to contact the child's:**
 - (i) Parent at the parent's home or place of employment;**
 - (ii) Family physician; and**
 - (iii) Preferred hospital;**
 - c. The name of each person who is designated in writing to pick-up the child;**
 - d. The child's general health status and medical history including, if applicable:**
 - (i) Allergies;**
 - (ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and**
 - (iii) Permission from the parent for third-party professional services in the child-care center;**
 - e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;**
 - f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;**

Findings:

General: Based on review of documentation presented to the surveyor for review, the surveyor discovered that two (2) children's (DOE: 08/31/2020) files did not have a family physician or a preferred hospital listed on their enrollment forms.

Staff reported that the family just moved to the area and was looking for a family physician.
